## **Laguna Seca Shooting Sports Association Membership Requirements**

1. All LSSSA members must be active members, in good standing, of the National Rifle Association of America (NRA). If not a member of the NRA, LSSSA Applicants will become NRA members upon joining this organization.
2. Any citizen or legal resident of the United States who has reached their eighteenth birthday may become a **Provisional Member** of this organization, after submitting a completed application, payment of dues, a vote of the majority of the Executive Committee, and after subscribing to the following pledge.

### **THE NRA PLEDGE**

*“I certify that I am a citizen of good repute of the United States of America; that I am not a member of any organization or group having as its purpose or one of its purposes the overthrow by force and violence of the Government of the United States or any of its political subdivisions; that I have never been convicted of a crime of violence; and that, if admitted to membership, I will fulfill the obligations of good sportsmanship and good citizenship.”*

3. An applicant will remain a **Provisional Member** for one year, in accordance with the Bylaws of this Association, after which time they will automatically become a full member. 4. Children of members under the age of 18 years may apply for Associate Membership.
5. Mandatory Attendance:
  1. One Monthly Meeting per half year
  2. One Match per half year
  3. Annual Meeting

Any member not complying with the preceding MEMBERSHIP REQUIREMENTS, and as outlined in the Bylaws of this Association will, upon the request of the President, come before the General Membership at the next Monthly Meeting. At that time a vote will be taken on the continued membership of that individual.
